

INLAND WATER BIOLOGY

GUIDE FOR AUTHORS

Inland Water Biology publishes original and topical manuscripts which deal with biology, morphology, systematics, ecology, and ecological physiology and biochemistry of hydrobionts; ethology of aquatic organisms, and their populations and communities; aquatic toxicology, patterns of the biological cycle; the structure and functioning of aquatic ecosystems; anthropogenic impact on aquatic organisms and ecosystems; protection of aquatic ecosystems and organisms, and the methods of hydrobiological research. All papers are reviewed and considered by the Editorial Board. The main criteria for publication of the manuscript are the importance of the problem, novelty of the results, validity of conclusions, and clarity. Review articles should provide a new insight into the problem and propose new areas of research.

The journal is translated into English by Pleiades Publishing, LTD. The English version of the journal is published simultaneously with its Russian version under the title of *Inland Water Biology*. The Editorial Board encourages authors to follow the following guidelines:

1. Manuscripts should be accompanied by the copyright transfer agreement with Pleiades Publishing, Ltd in an electronic version (the agreement form is provided at the website <http://pleiades.online/authors/agreement>).

2. The submitted manuscript (including references, tables, and figures) should not exceed 32 000 characters with spaces.

3. The first page of the manuscript should be arranged as follows: (1) title of the article; (2) initials and surname (s) of the author (s); (3) authors' affiliations with the full postal addresses; (4) the e-mail address of the corresponding author.

The abstract should state briefly the purpose of the research, the principal results and major conclusions. Then it follows by keywords, the text of the manuscript and the list of references.

4. The manuscript should have the following structure: INTRODUCTION, MATERIALS AND METHODS (please avoid describing commonly known published procedures, but describe all substantial modifications used by the author); RESULTS (presented in a logical order in the text, tables, and figures; only the most important observations or experimental results should be noted in the text; do not duplicate information presented in tables and figures); DISCUSSION (the significance of the results, their place alongside other studies of the subject, possibilities and limits of application, and further research goal);

CONCLUSIONS, ACKNOWLEDGMENTS, and REFERENCES. Other necessary headings (except headings of review articles) should be placed at the beginning of the corresponding paragraph. A brief communication should not be divided into separate sections; the text should not exceed 10 pages, including tables and references, and should include no more than 1–2 tables and a figure. A list of references should include no more than 10–15 sources.

5. The manuscript should be submitted as an electronic file in Microsoft Word 2003 format with the following margins: top, 2.5 cm; bottom, 2.5 cm; left, 2.5 cm; right, 1.2 cm. The text, tables, and footnotes should be Time New Roman 12-point font, double-spaced (2.0). All the pages of the manuscript should be numbered in the upper right-hand corner.

6. Abbreviations (except common ones) when are unavoidable are given as footnotes at the bottom of the first page of the manuscript in an alphabetical order. The International System of Units (SI) is used. The accepted units in the journal are: base pair (bp), kilo base pair (kbp), dalton (Da), kilodalton (kDa); minutes (min), seconds (s), days (d), months (m); micrometer (μm), nanometer (nm), picometer (pm); millimole (mM); multiplicity is denoted by a multiplication sign.

7. Formulas which have references in the body of the text should be indented and numbered. The radical sign should be avoided and replaced by a fractional exponent. A decimal point is represented by a period, and a multiplication sign is indicated by a centered dot. Subscripts and superscripts should be explained. Headings and the text are typewritten in lowercase letters except the first letter at the beginning of the sentence and proper names. The species names of hydrobionts when they are first mentioned should be in Latin with an indication of the author. Taxonomic names: genera and species should be in *italics*.

8. The list of references should be arranged according guidelines for the journal. Cited literature should be compiled in a list titled REFERENCES (on a separate page) at the end of the manuscript. References should be arranged in the alphabetical order and should not be numbered. Please quote all the authors in the works until four authors; after four authors quote first three authors followed by the expression et al. If several papers are of the same first author, references should be sorted according to the second author. If several works by the same authors are cited, references should be arranged in a chronological order (i.e. earliest first). If works published by the same first (second etc.) author in the same year are quoted, they should be differentiated by adding a lower case letter directly, with no space, after the year of publication: 2007a, 2007b. In this case, lower case letters after year of publication are used in in-text citations (Ivanov et al., 2007a, 2007b).

References to books should include: authors' surnames and initials, title of the book, year of publication, city, publishing house; articles in a collection of articles should be cited as follows: authors' surnames and initials, title of the article, title of a collection of articles, year of publication, city of publication, publishing house or publisher, the first page of the article; items for references to articles in journals (bulletins) should appear in the following order: authors' surnames and initials, title of the article, title of the journal, year of publication, volume, number or issue, the first page of the article.

In-text citations should be given in round brackets (Edwards, 2007). If more than two authors, use et al. after the first author: (Froese, Pauly, 2012; Jordan et al., 1932). References to unpublished works can be provided in footnotes.

9. Tables should be typed double-spaced on separate sheets. They should not duplicate the text. All dimensions of quantities should be placed in side and top headings. Units should be separated by a comma (for example: length, m). Tables are numbered with Arabic numerals in the order of their appearance in the text (e.g. Table 1). The number of a table is followed by its title. Each table has a short title. Tables should be compact, easy-to understand, and easy-to publish in the journal. Similar tables should be uniformly formatted. The main body of the table should not have horizontal lines (except those delineating column headers). Unfilled columns are not allowed; the absence of data is denoted by a dash. Numerals in tables should be placed strictly in correspondence to their class, i.e. integers under integers, decimal under decimals. If numerals are given in the column, and they are repeated, use the same numerals instead of quotation marks. Abbreviations are not allowed.

10. Figures submitted should have resolution of no less than 300 dpi and be high-contrast. Please, minimize the text in the figure and use letters or numerals that are explained in the figure caption. The figure should be no less than 5 × 6 cm and no more than 18 × 24 cm. The number of the figure, the surname of the first author and the title of the manuscript should be below the figure.

Figure captions should be typed on a separate page. The data which can be presented as a table should not be submitted as a figure. All letter and numerical symbols in a figure should be explained in the figure caption. Geographical names on maps should be minimal and include only those necessary for comprehension of the text; water bodies should be in italics (*Missouri River, Lake Baikal*).

11. To describe your studies better, the article can be supplemented with various additional files (audio- and video files, presentations, supplementary tables, and illustrations etc.) provided that the author reserves the right for this supplementary material that has not been granted to others or the author

has written permission to use these materials for the purpose of publication in the journal. Supplementary materials are published online only in English-language journals at <http://link.springer.com>.

Electronic proofs will be sent as an e-mail attachment to the corresponding author as a PDF-file. Files can be read and edited using Adobe Acrobat Reader. Comments should be added to a PDF-file of the manuscript. We do not recommend use of other programs to correct PDF-files; otherwise changes and notes may be lost during automatic processing of PDF-files. For the same reason, the name of a PDF file and subject of the e-mail message must not be changed. Recommendations for making corrections in a PDF file are at the website <http://pleiades.online/ru/authors/guidlines/electronic-proofreading>.

The Editorial Board reserves the right to abridge and edit the text if necessary.

If a manuscript is returned to the author for further improvement, the date the article is received is considered from the moment when the Editorial Board receives the final version if the period of revision exceeds two months.

Proofs will be sent via e-mail to the corresponding author. Manuscripts which are non-compliant with the guidelines will be returned to the authors without consideration.

The Editorial Board of the journal wishes the authors every success in their scientific research and will provide all kinds of support for publication of novel interesting results.
